Looking to June...



Classic Mineral Localities of Virginia

5-year Strategic Plan

Due to COVID-19 and the inability for travel, data collection for 2019 was less than originally hoped for. We are still needing individuals with specimens and collections to send in their stories as they relate to our classic locations and would like to encourage photographs, even if temporary, of specimens you feel should be put in the publication. During times like these, it is imperative that we continue to work towards the end goal and push through any hurdles that may present themselves. The VMP has developed a new timeline for the development of a new publication on Classic Mineral Localities of Virginia.

This five-year strategic plan highlights the goals and objectives of the Virginia Mineral Project (VMP) and the Friends of Mineralogy Virginia Chapter (FMVA) to update and publish a new book on the state's classic mineral localities. Below is a section from the plan highlighting the objectives and first year localities.



Objectives for 2020-2021:

- Complete ten locality sections of the book and have them ready for editing and proofing.
- The previous years localities will then be sent to editors and volunteers for review.
- The format of these locality reviews mean that they can, if necessary, act as single publications in the future.
- Creative changes to individual reports can occur past the editing phase but it does mean that the report should be 95% completed in its design and format by the end of the year.
- Photographs can change, but there should be an understanding of what the image is trying to convey and what we are looking for if new photographs come up.
- Co-authors and assistants on the chapters can continue their work past the one-year mark if they need.

Some Recollection of the Early Days of Our Society: GLMSMC

Our first meeting was held at the Rockville COOP Market in the early to mid part of 1963 (I do not have an exact date). Knight and Dottie Porter had posted circulars around various places in the county announcing a meeting for anyone interested in rock, mineral, fossil collecting, field trips, and lapidary. The main objective was to determine if there was enough interest by those attending to form a club in the Montgomery County area. (Membership was not restricted to Montgomery County.)

There were already well-developed, successful societies (clubs) established and operating in the Washington, D.C., Maryland and Virginia areas at that time.

Approximately 15 to 20 interested persons showed up for the meeting and it was generally agreed to schedule more meetings to organize and develop a club. For the most part, those in attendance showed interest and offered their help and services to get organized, but for one reason or another did not sign up at that first meeting. Dottie, Knight Porter, and Dan Spielman were the only names on the sign-up sheet at the first meeting.

After several meetings and interest increased to where organizing into a club was practical, an election was held. With officers in place, committees were formed and basic rules of order were established while a Constitution and By-laws were being drawn up. It was decided in the course of organizing that Junior members would have their own club and officers within the main club to develop projects according to their interest, with the approval of the main club. With By-laws and Constitution drawn up, revised, and finally accepted, Incorporation was the next step. Phil Marcus, member and legal advisor, devoted much time and effort in preparation of necessary papers and documents to secure our Incorporation status.

Dottie Porter, our first elected president, had also been Chairperson/Coordinator at our meetings leading up to club development and elections. The "Rockhounder," our monthly bulletin and newsletter, was edited by Dottie Porter for quite a few years. The newsletter included Minutes from the Regular meeting, the Board of Director's meeting, other club business, information about field trips, shows in the area, and other tidbits concerning the various phases of club interest. Fairly early on, our society became a member of the Eastern Federation of Mineralogical and Lapidary Societies, Inc., and Affiliate of the American Federation of Mineralogical Societies.

Shows; field trips; exchanging information; working with and displaying rocks, gems, minerals, and fossils were all important phases of our club's operation.
